THE BUDGETARY FINANCING IS IN THE AGRARIAN SECTOR OF ECONOMY OF UKRAINE

Enterprise agrarian to the sector unable independently to satisfy requirements in providing financial resources by own forces, that is why first of all a necessity appears for providing from outsourcing.

Due to credits there is forming of the fixed assets and turnover means, calculations come true between commodity producers, there is an increase of volume of amount of money, the processes of the real accumulation, productive and social development of enterprises are accelerated agrarian to the sector [4].

Conducting the study of experience of adjusting of financial and state support agrarian to the sector in the developed countries ground to do next conclusions:

- most countries carry out politics of state influence on development of agriculture mainly economic methods [3];
- state support envisages realization of the having a special purpose financial programs through financing of separate types of activity, favourable crediting [3];
- favourable influence of taxation exists practically in entire countries and realized mainly through establishment of minimum rates of taxation and providing of the assured untaxed minimum [3].

The specific of economy of our country is unable fully to adopt experience of the developed countries, but she must promote the results of mechanisms of state control. However, forming of the integral system of government control with the aim of warning of possible cases of origin and minimization of the crisis phenomena needs changes mechanism of adjusting of public policy.

On the basis of undertaken a study, it is possible to assert that state support of development agrarian to the sector does not have the proper efficiency and control. In particular, financial providing agrarian to the sector of economy is insufficient, and the existent mechanisms of fiscal politics do not give positive results. For the sake of minimization of the crisis phenomena and improvement of the system of the budgetary financing and support, it is necessary to carry out the proper control after activity of budgetary establishments with the aim of support agrarian to the sector, and also modernisation of the specialized establishment with the aim of realization state
