ECONOMIC ORIENTATION OF TRADE UNION COMMITTEES IN STUDENT ACTIVITIES

The Primary Trade Union Organization of Students, which represents, promotes, and protects the educational, financial, and social rights of its members, is a voluntary non-profit organization whose purpose is to promote and protect the educational, financial and social rights of its members. Any student studying at a

university on a full-time basis who recognizes the Statute of the Trade Union of Education and Science of Ukraine can become a member of the trade union. Trade unions are established to defend and protect the labor, financial rights, and interests of members organizations [2].

The purpose of the economic orientation of student union groups in student activities is to promote and protect the financial interests of students. These committees function as intermediaries between students and the university administration, ensuring communication between students and the financial department regarding their studies and personal endeavors. The unions promote fair conditions for scholarships and social benefits for students, especially those with financial problems or special needs, and the committee's responsibilities include providing students with discounts on travel, food, medical care, and other services that reduce their financial burden [2].

Trade union committees in higher education institutions perform a number of economic functions aimed at protecting the financial interests of students. The main areas of activity are:

- distribution and control of scholarships;
- providing financial assistance;
- participation in the formation of the university budget to finance student programs.

One of the key economic functions of trade unions is to participate in the process of setting the amount of scholarships and other financial incentives. Studies show that the active participation of trade union committees in these processes allows for more effective protection of students' interests and helps to improve their living standards [3].

The involvement of trade union committees in the student environment has a significant economic impact, as it protects the rights and material interests of students. Trade unions are an important tool for higher education institutions in distributing scholarships, providing financial aid, and shaping economic policy. Their efforts play a key role in improving the living standards of students, promoting

transparency of financial transactions, and creating an environment conducive to the economically sustainable development of student communities.
